### **Emergency Services Department:**

The Board suggested that Chief Miller look for an engine that will meet the department's needs. 2) Slucter moved and Rumsey seconded to: move Brad Wilbur from Pool Paramedic to the open Full time Firefighter Paramedic position; Megan DeClercq, Jeffrey Carrow and Kaleb Benjamin, once Kaleb gets his paramedic license, be given a higher rate of pay to reflect their years of service; and approve the department sponsoring Adam Miller, currently a Pool Paramedic, for the Eaton County Fire Academy. Carried: 7-0.

Deputy Holliday reported no major incidents in the township. There was however some beehive's stolen in Benton Township.

Supervisor Braman reported on the MDOT meeting last Thursday on the proposed roundabout at Canal and Lansing Road. There were some disagreements between the township and MDOT on whether there is a safety problem at this intersection. MDOT is of the opinion because the township isn't excited about a roundabout that we are opposed to spending money for safety. Braman wants to emphasize that the township is not opposed to spending money for safety. According to the township's information there isn't a safety issue and MDOT has yet to prove there is one. MDOT intends to have future meetings.
